APPLICATION PROCEDURE

1. The parent/guardian submits an application form (see reverse) on behalf of the girl, to the Area office – where it will be forwarded to the Provincial office.
2. The “Supporter” for the application must be an adult who is familiar with the girl’s circumstances in the Supporter’s role as a teacher, principal, religious leader, or professional in social work or family services. If none of these are available, a parent’s employer may be acceptable as a Supporter. The Supporter must be from outside the Girl Guides of Canada organization.
3. The application will be reviewed by a committee for approval.
4. If the application is approved, the national and provincial portion of the registration fee will be paid directly by the provincial office. The balance of the fee has been included with this application and will be forwarded appropriately.

IMPORTANT NOTICE

Project Lend a Hand has limited funds to assist with membership/registration fees. Applications received after the funds are spent will be advised that assistance through Project Lend a Hand is not available and another funding source must be explored.
